We expect these rules to be followed throughout your stay here at Smith Lake Park.

Please always have your campsite clean and orderly.

Campers in violation of any rules will be asked to leave. While camping here you agree to obey by all rules.

- 1. Only two vehicles per campsite. No parking on vacant campsites, additional parking in the overflow. Towing may occur, if parked on unauthorized camp site.
- 2. ALL CAMPSITES ARE BACK IN. This means tongue of the camper, front of the RV facing the road.
- 3. Camping fees do not include special event charges, which shall include, but not limited to: Firework Festival and Sweet Tater Festival.
- 4. Maximum Camping 28 days straight. Then must leave campground for 14 days.
- 5. Cullman County Requires that all persons registering at any cabin or campsite shall record their name, phone number, and driver's license number prior to staying. Any person who willfully make an erroneous entry/registration shall be in violation of this regulation.
- 6. Camping fee or coupon must be received upon arrival each day. If arrival occurs after hours, office drop box shall be used. Camp site cards or nightly camping cards must be clipped on your site post upon arrival.
- 7. There is a \$20 per day late charge if not paid before or on the date that you are originally due to check out. After the third day you will be violating this agree and will be asked to evacuate the campground.
- 8. No subleasing of your campsite will be permitted.
- 9. One picnic table is allowed per campsite. Do not move any tables from other sites.
- 10. Recreation items such as horseshoes, corn hole, etc. must be picked up when not in use.
- 11. No pallets, lumber, or plywood can be at any campsite only true firewood.
- 12. No ATV, UTV, dirt bikes, or 4wheelers of any kind allowed.
- 13. It shall be a violation of this agreement to erect or occupy any site with unsightly, inappropriate, or permanent equipment/structure, which includes but is not limited to decks, outbuildings, fences, dog houses, dog crates, storage containers, appliances, clothesline, swimming pools, fireworks, etc. No outside trash cans. No furniture outside when not occupied.
- 14. It shall be a violation of this agreement should your site not be kept in a clean and orderly manner. This includes under your camper as well. Upon departure, you must leave the premises in a clean and sanitary condition.
- 15. It shall be a violation of this agreement for any person to evade payment or attempt to evade payment of any fees or other charges which may be levied for admission to, or use of, any park area or facility contained therein.
